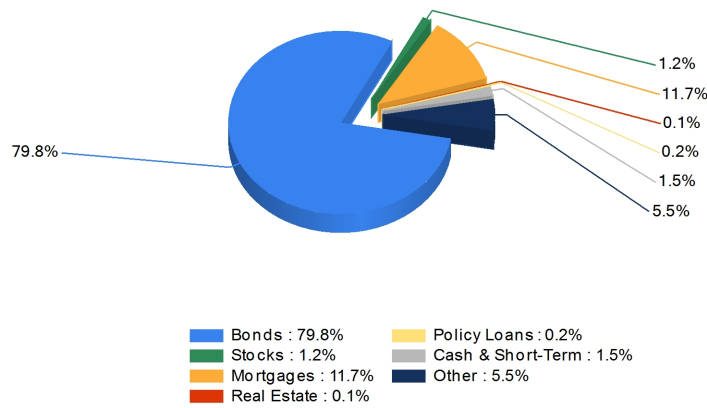

## Invested Asset Distribution

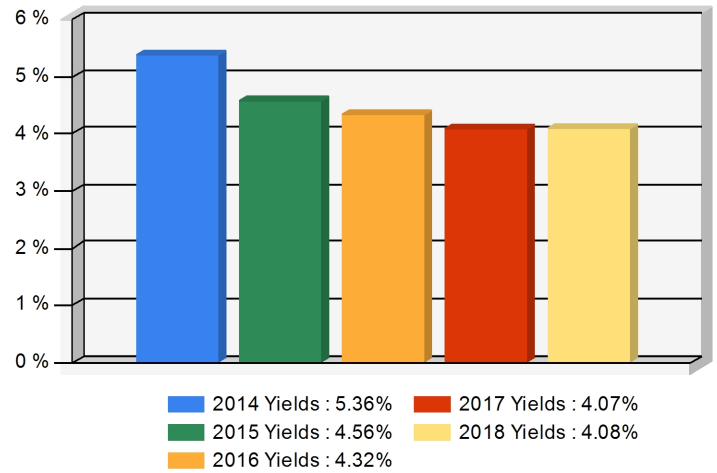
Total Invested Assets 121,869,252

Net yield on mean invested assets

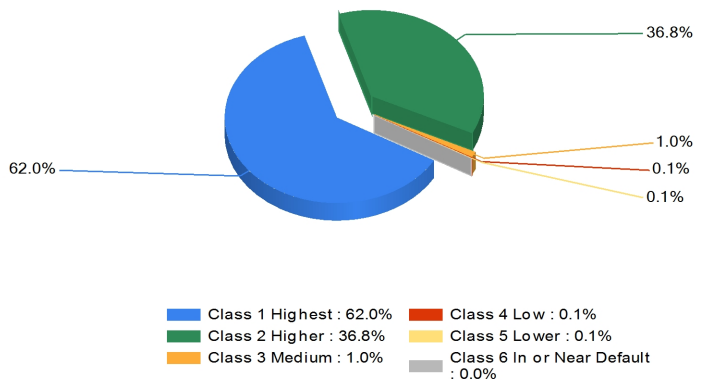
